Privacy Policy



PU Prime is the commercial name of PU Prime Limited which is authorised and regulated by the Financial Services Authority of Seychelles under number SD050 with Company registered in Seychelles and located at CT House, Office 1A, Providence, Mahe, Seychelles and PU Prime (CY) Limited registered in the Republic of Cyprus with registration number HE414308 and registered address at Archiepiskopou Makariou III, 160, 1st floor, 3026, Limassol, Cyprus (The "Company", "us", "we", "our", "ours" or "ourselves" as appropriate). PU Prime (CY) Limited is acting as PU Prime Ltd appointed independent representative and distributor.

This privacy statement covers the website www.puprime.com, and any other related websites that are registered and operated by PU Prime.

Application

In order to open an account with PU Prime, you must first complete and send the application form attaching the required documents. By completing the application form, you are requested to give private information in order to enable PU Prime to evaluate your application and comply with Laws and Regulations governing the provision of services. This information is also used to contact you about trading services.

PU Prime shall not disclose to a third party, any of its clients' confidential information unless required to do so by an authority of a competent jurisdiction; such disclosure shall occur on a 'need-to-know' basis, unless otherwise instructed by the authority. Under such circumstances, PU Prime shall expressly inform the third party regarding the confidential nature of the information.

Clients accept and consent that PU Prime may, from time to time, contractually engage companies for statistical purposes in order to improve the Firm's marketing; as a result, some or all of the clients' personal data may be disclosed on an anonymous and aggregated basis only.



Agents

We use card processing companies for your deposits and withdrawals to and you're your account. These companies do not retain, share, store or use personally identifiable information for any other purposes.

Privacy

Website tracking systems may also collect data detailing the pages you have accessed, how you discovered this website, the frequency of visits and so on. When you visit our website, we can view your IP address. However, your IP address does not identify you as a user, but merely the general area of where you live. Cookies

A cookie is a small text file that is stored on a user's computer for record-keeping purposes. We may use cookies on the website. We do link the information we store in cookies to any personally identifiable information you submit while on our website. We may use both session ID cookies and persistent cookies. A session ID cookie does not expire when you close your browser. A persistent cookie remains on your

hard drive for an extended period. You can remove persistent cookies by following directions provided in your Internet browser's "help" file.

We may set a persistent cookie for statistical purposes. Persistent cookies also enable us to track and target the location and the interests of our users and to enhance the experience of our services on our website.

Some of our business partners may use cookies on our website. We have no access to or control over these cookies.

Security and Protection of your personal information

The personal information that you provide in connection with registering yourself as a user of the website or of the services is classified as Registration Information. Registration Information is safely stored on secure servers that only authorised personnel have access to via password. PU Prime encrypts all personal information as it is transferred to PU Prime and thus makes all necessary effort to prevent unauthorised parties from viewing any such information.

Personal information provided to PU Prime that is not Registration Information also resides on secure servers and is again accessible only to authorised personnel via password. This information cannot be online accessible by you; therefore, no password shall be selected to view or modify this information.
